- The Regulations on Graduate Medical Education Amendment, May, 2018.
- The Central Govt. "Policy guidelines" on Admission of students and charging of Fee in Private medical and dental colleges and other Professional Institutions imparting education in health sciences in pursuance of the directions of the Hon'ble Supreme Court in the Judgment dated 31.10.2002 in the TMA Pai Foundation Case (vide letter No. V-11025/1/2003-ME (P.I) dated 14th May 2003) Islamic Academy & P.A. Inamdar & State of Karnataka.
- The State Govt. directives 2009, (Justice Israni Committee recommendations).
- The Rajasthan University of Health and Sciences Act 2005.

Medical Council of India Gazette Notification Dated: 22.01.2018, 05.02.2018 & 18.05.2018.

Note

- 1. The medium of teaching and examination for MBBS course shall be English
- 2. Course Duration the duration of course is 4½ years, followed by one year compulsory rotating Internship Training.
- 3. Number of Seats 150

Categories of Seats

- 1. State Quota Seats 85% of the total annual intake (127 Seats)
- 2. Foreign Nationals / PIO / Children or Wards of NRI (In short called "NRI seats")- 15% of the total annual intake (23 Seats)

NRI Seats

As per order no. F.5(968)DME/LC/2018/1997 dated 29.04.2019 of Government of Rajasthan (Annexure-2), following will be the guidelines applicable for the admission in under Graduate/Post Graduate, Medical/Dental courses under NRI quota in all private and Government, Govt. Society institutions and RUHS CMS of the state:

- 1. At least one the parents of students should be an NRI and shall ordinarily be residing abroad as an NRI: or
- 2.The person who sponsors the student for admission should be a first degree relative of the student (i.e. real Brother/real Sister) and should be ordinarily residing abroad as an NRI; or
- 3. If student is taken as a ward by some nearest relative (as mentioned below (i) to (v) such students also may be considered for admission provided the guardian has bonafidely treated the student as a ward. For this following nearest relative (NRI) of candidate, who should be ordinarily residing abroad as an NRI can only be considered:
 - (i) Real brother and sister of father i.e. real uncle and real aunt.

- ii) Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
- (iii) Father and mother of father i.e. maternal grandfather and grandmother.
- (iv) Father and mother of mother i.e. maternal grandfather and maternal grandmother.
- (v) First degree-paternal and maternal cousins.
- 4. All NRI Candidate shall submit a proof being sponsor as NRI/OCI/PIO in the form of certificate issued by the Indian embassy/MInistery of external affairs, Government of India for this purpose. In the absence of that certificate a duly notarized undertaking executed by the sponsor and notarized by the Notary Public of the foreign country where the sponsor resides being submitted by the sponsor, it be treated as sufficient as to the factum of the residence of the sponsor.
- 5. An affidavit from the sponsor that he/she looks after such student and will sponsor the entire course fee of the candidate.

Selection Procedure & Admission

Admission on NRI Quota seats (Foreign National/children or wards of NRI/PIO/OCI) and State Quota seats in MBBS course for the academic year 2020-21 respectively in Ananta Institute of Medical Sciences & Research Center, Rajsamand (owned & managed by Ananta Charitable Educational Society, Udaipur) shall be made on merit basis from amongst NEET UG-2020 qualified candidates by the State Government Admission/Conselling Board "NEET UG Medical and Dental Admission/Counselling Board-2020" constituted by Government of Rajasthan.

As per the Notification of the Office of the Chairman, NEET UG Medical and Dental

Admission/Counselling Board - 2020 issued on June 14th, 2018 the process of NEET UG Counselling (Rajasthan)-2020 for NEET qualified candidates will start ONLINE from 18th June, 2018 the detailed information booklet and other program of the Counselling are available on the website of the "NEET UG Medical and Dental Admission/Counselling Board-2020"

Note for Application Form - Ananta Institute of Medical Sciences & Research Center

The application form can be downloaded from the college website (www.anantamedicity.com). The downloaded application form shall be accepted only with the cost of the application form amounting to Rs. 5,000 in cash (to be deposited in the College Accounts Department) or through Bank Draft in favour of Ananta Institute of Medical Sciences & Research Center, Udaipur, Payable at Udaipur (Rajasthan)

The application form is required to be completed by the applicant himself/herself.

Application form fee shall not be refunded in any case.

Downloaded application form, complete in all respects along with necessary enclosures

Admission Application forms shall stand rejected, if

- 1. Forms are incompletely / wrongly filled.
- 2. Necessary Enclosures are not attached.
- 3. Not filled as prescribed.

Legal Jurisdiction

All disputes in relation to the matters pertaining to the admissions in the course shall be subject to the jurisdiction at Udaipur (Raj) Court or Jodhpur (Raj) Bench of Hon'ble Rajasthan High Court only.





University Enrolment

All the selected candidates admitted to the first MBBS course at Ananta Institute of Medical Sciences & Research Center, under any category, are required to apply to the Rajasthan University of Health & Sciences, Jaipur on a prescribed proforma with the required fee for registration as per rules and regulations of the RUHS Jaipur. The admitted students must apply for enrolment as per the notification of the RUHS.

Migration

No application for migration to other Medical Colleges will be entertained from the students admitted to the MBBS course at this institute. The Chairman may grant NOC for migration of a student in the exceptional circumstances. However, the final approval will be granted by Medical Council of India.

Cancellation of Admission & Withdrawal from the course

The admission of the student, who has paid the admission fee but fails to join the course at the institute within the time limit communicated, is liable to be cancelled, and the tuition fee paid will not be refunded.

In case, the Eligibility / Equivalent certificate is not produced by the candidate within two weeks, his / her selection for admission to the MBBS course is liable to be cancelled.

The prescribed fee once paid shall not be refunded in any case. If after registration any student withdraws from or discontinues the course he / she shall have to pay the entire course fee. Only items mentioned as deposits (interest free refundable amount after adjustments, if any) in the fee structure will be refunded.

Anti Ragging

Ragging of fresher / junior is strictly prohibited in and outside the campus of the university. Those, who are found guilty of ragging / abetting ragging, shall be punished severely as per the relevant regulations of the MCI / DCI and the provisions of the Act of the Central Government and the State Government.

"Ragging" includes the following:

Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling

with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will



not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

Punishable ingredients of Ragging:

- Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body, causing hurt or grievous hurt;
- Wrongful restraint;
- Wrongful confinement;
- Use of criminal force;
- Assault as well as sexual offences or even unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of the above mentioned offences against the victim(s);
- Physical or psychological humiliation.
- All other offences following from the definition of Ragging.



Ragging shall be considered as a cognizable offence under the law at par with rape and other atrocities against women and ill treatment of persons belonging to the SC / ST. Strict action shall be taken against those found guilty of ragging or of abetting ragging. Each student is required to give an undertaking in printed Performa to the effect that he / she is aware of the law regarding prohibition of ragging as well as the punishment and further that he / she has not been expelled and / or debarred from admission by any institution and he /

> she if found guilty of the offence of ragging and / or abetting ragging is liable to be punished appropriately including even arrest by Police.

> A student seeking admission to the hostel shall also have to submit additional undertaking along with his /her application for hostel accommodation.

Awardable Punishments at the College / Institution level:

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

- Suspension from attending classes and academic privileges.
- Withholding / withdrawing scholarship / fellowship and
- Debarring from appearing in any test / examination or other evaluation Process.
- Withholding results
- Debarring from representing the institution in any regional, national or international meet,
- tournament, youth festival, etc.
- Suspension / expulsion from the hostel
- · Cancellation of admission.
- Rustication from the institution for period ranging from 1 to
- Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.
- Fine of Rs. 25,000.00 and Rs. 1 lakh.
- Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective Punishment.










Practical Zone

Knowledge Treasury




Sports Ground







